## Frequently Asked Questions

### What types of Drake Software will follow this new policy?

Drake Tax, Conversions, and Drake Accounting software

### When does this change take effect?

Per customer communication, this new policy will go into effect August 1, 2025.

### To what years will New Sales have access?

New Sales will be able to download 2018 – 2023 as unlimited with their purchase of Drake Tax 2025.

Drake Tax 2024 is provisioned in PPR mode with 0 returns in the bank by default with their purchase. This will generate a PPR serial number, but they will have to purchase returns before they can create/file. They can upgrade to unlimited for \$300.

**ONLY UPON REQUEST:** If a New Sale requests software prior to 2018 (e.g., they specialize in tax resolution work), we can provide them a link to download 2016 and 2017. Corresponding serial numbers will be available in their online account. **It is important that software prior to the most recent seven years is only provided upon request.**

## **To what years do existing customers have access?**

Existing customers will be able to download Drake Tax 2018-2024 from the support website. Availability in the download center has no impact on their ability to access and use older versions of the desktop software.

## **Is it possible for a customer to get access to prior years of Drake Tax that aren't available online (download outside 7-year window)?**

The download center will only include the most current seven years. 2017 and prior are not available online.

If they specifically request access to an older year and have a serial number for that year, an exception may be possible on a case-by-case basis (e.g., someone requesting prior software for tax resolution work). If the customer insists that they need a version of the software that is no longer available in the download center, escalate the request to the [CServices team \(CRMT\)](#).

## **Can we provide prior-year software or serial numbers upon request?**

Generally, customers will only be able to download the programs that are available online (see above for details). In addition, they will need to retrieve their assigned serial numbers by logging into the support site.
